COLLECT OF DATA PERSONNEL

NCC collects personal data that you provide to us directly when requesting information about our services, to the to sign ours services of website, notifications put e-mail and or bulletins of news, when submitting a question through our inquiry forms and call centers or placing an order through our website.

AS WE SHARE DATA PERSONNEL

Otherwise, and in accordance with our internal procedures, we will respond to the following requests as described below. Access to personal information: You have the right to know what personal information about you the NCC keeps, subject to the our right of confirmation of identity. If you If you request a copy of your data, we may charge a fee, unless local law prohibits it.

Correction and exclusion: in some places, including in the EU (of agreement with to the laws of protection of data to holders of data from the EU), you he has the right of to correct and to alter your data personal, if incorrect or if need to be updated. You also he has the right of request the deletion of your personal data; however, this may not always be possible due to legal requirements and other data retention obligations.
